Starke Arvid Board Trolley

The Starke Arvid Board Trolley is a plasterboard/sheet material transporter.

Because of its width the Board Trolley provides excellent manoeuvrability for limited loads of plasterboard or other sheet materials, even through narrow door openings.

The Board Trolley is supplied with two swivel casters, one with brake and also two large fixed wheels.

We would recommend that the fixed wheels are used at the lead end of the Board Trolley when the trolley is loaded to prevent undue damage to the swivel castors.

The removable vertical support bars must always be fully secured when in use.

The Starke Arvid Board Trolley is designed for internal use on flat and level surfaces only.

Starke Arvid would recommend that when transporting boards using the Board Trolley it should be carried out as a two man operation, with one at the front and one at the back of the trolley.

The Board Trolley should only be pushed on the line of the board and at no time should any force be exerted across or at an angle to the width of the trolley. Starke Arvid would also recommend that the Board Trolley is used to transport no more than 12no 2400x1200x12.5mm standard wallboards or the equivalent weight in other types of plasterboard/sheet materials

Local site conditions may require fewer boards are carried and this should be determined by a risk assessment before work starts.

The Starke Arvid Board Trolley has been designed specifically to carry plasterboard/ sheet materials as recommended in our notes but its actual use on site is beyond our control.

It is very important that worn or damaged wheels are replaced immediately before further use of the Board Trolley. Also we recommend that assessments are carried out regularly and that any worn or damaged parts within the Board Trolley are to be replaced/repared immediately.

Health and Safety
